These quotations will be opened on the same day by 4.30 P.M. in presence of the quotationers / their authorized representatives.

Particulars

1. Printing of book in the name and title of "Shreejagannath Pancharatra Padhhati" and "Shreejagannath Mandir Nirmana and Sevapuja" in Odia Language 1000 copies and books containing 46 and 56 inner pages respectively.

Technical Specification :

- a. Size of books – Demy 1/8
- b. Paper – 60 GSM (Siripur/Sewa/Bilt)
- c. Cover Page – 170 GSM Art Paper in 4 colour print

The price should be quoted separately for printing charges of offset printing, DTP charges, cover printing with lamination charges, cost of cover papers, binding charges and cover – design charges for the books to be printed.

Specimen of papers for books should be enclosed with the quotation.

The press whose quotation will be accepted shall execute an agreement to the effect that they have to print the books shall not sale/issue the copy of the same in any manner to any individual or firm.
